Grieving parents receive a belated Christmas present

A centavo bill issued by the Japanese Government during WWII as it invaded the Pacific uncovers a dramatic story — one that happened on the home front.

The bill was discovered in a box of foreign currency at a store in Largo, Florida, and shared with the North Wood County Historical Society. It includes a few scribbled names and places, one of them R. W. Stoiber of Marshfield.

Richard “Dick” Stoiber was a 20 year-old U.S. Navy third class ship fitter when he was reported dead in the Dec. 16, 1941 edition of the Wisconsin Rapids Daily Tribune. A navy telegram had stated he was lost in action at Pearl Harbor. He was on the U.S.S. California.

A requiem high mass was sung on Dec. 22 at St. John’s Catholic Church as Richard’s parents, Raymond and Ida Stoiber, spent the holiday grieving over the news of their oldest son.

But in a dramatic twist, they received the Christmas present of their lives when a letter postmarked Dec. 25 arrived at their N. Maple Ave. home the morning of Dec. 29 — their son was alive!

Both had already headed to work at the Roddis Lumber and Veneer Company plant and the Stock-Gro plant when their daughter Elaine called them to let them know the news. Mrs. Stoiber took the day off “almost delirious with joy” to go home and read the words that brought her missing son back to life.

Word spread quickly through the city and the Stoiber’s telephone was kept ringing as disbelieving friends called to verify the rumors.

In an interview with the paper, Mrs. Stoiber said there was always doubt in her mind and she hadn’t stopped praying for her son’s safe return.

Richard’s letter revealed nothing about his location, but he verified that he was okay, though he had lost all of his possessions. Apparently unaware of his status back home and the subsequent grief it had caused, he said, “This Christmas isn’t so merry, but I can be thankful at least that I am still alive.”

He explained that circumstances prevented him from writing any sooner but he had worried they might think he wasn’t okay. While the speed of the letter’s arrival indicated Richard wasn’t far from the coast, his parents and four siblings were content not knowing exactly where he was — just as long as he was alive.

In October 1943, Richard, now a petty officer first class, married Virginia Braem where he was stationed in Bremerton, Washington. Both had graduated from Marshfield High School.

Together with Ginny, Richard enjoyed attending many U.S.S. California ship reunions around the nation as well as Pearl Harbor anniversaries in Hawaii. Richard died November 24, 2001.

Slim (Norma) Regenfuss was born in Marshfield, Wisconsin on October 16, 1905. The Regenfuss family lived on East Fourth Street. After her mother died, she and her father, J. J. Regenfuss, lived with the Rudolph Kerske family. Her employment consisted of housekeeping jobs, which paid \$3.00 a week, and she was a ward attendant at the Wood County Hospital.

The reason I want to write this story about Aunt Slimmy is that she was the First Santa for the City of Marshfield. She was brought into town either by sleigh and reindeer or by a fire truck. There was much excitement for the children that day. They would have her sit in one of the stores to give the children their bag of candy. After the candy was distributed, she would walk up and down the street to visit with the children.

Marshfield's Santa (Aunt Slimmy) also made appearances for the Nuns at Marshfield Parishes and one in Hewitt. Two or three nights before the appearances, Mr. Rembs would pick up Santa and two nieces Margaret and Mary Rose Kerske to prepare the gift bags. On the night of delivery, Mr. Rembs would take them to the parishes. It was a lot of fun watching the Nuns perform for their gift bags. Santa would have them sing a song or tell a story. The Nuns really enjoyed it, one trying to out do the other.

Santa (Aunt Slimmy) also visited nieces and nephews. When they started to get "too smart", Richard, brother to Mary Rose and Margaret, took over the Santa appearances. He still has the original suit, beard and wig.

I hope this will bring back many memories of getting a bag of candy from Santa. On April 9, 1958 Santa (Aunt Slimmy) passed away, leaving many memories for all who knew and loved her.

Christmas was in the air at the Upham Mansion




A traditional decorated House greeted guests at the Upham Mansion this year.

Dawson, Frank J. Deckert, Jacob Esser, Carl A. Fehrenbach, Ray T. Finucane, John T. Fitzgerald, Clement T. Fleckenstein, John Hasselbalch, Oscar J. Hoffman, George A. Huntzicker, Henry A. Huth, Adolph A. Kleinheinz, John A. Kestel, R. L. Kraus, Helmuth C. Koenig, Melvin H. Kraus, Robert L. Kraus, Jacob Leinwander, Dr. William H. Lind, Thomas F. McDonald, Edward E. Mechler, John O'Connell, Mike M. Phillipi, Joseph L. Pinion, Dr. Walter G. Sexton, Thomas D. Spaulding, Frank A. Stauber, Albert Steger, Rev. Hubert J. Stehling (founder of Sacred Heart Catholic Parish, of Marshfield), Thomas J. Tuchscher and Hubert J. Weber.

Transfer members were J. H. Burns, J. C. Byrnes, Larry Clark, George Dickof, John Esser, A. Michael Griffin, Ed Horgan, Anton Kleinheinz, Erhard Kleinheinz, Henry Lorge,

Joe Lorge, P. J. Lyons, J. J. McDonald, J. S. McDonald, E. C. Mechler, Leo Schoenhofen, and Frank E. Tice.

The original Council rooms were at the corner of South Central and East Fifth Street in the building now occupied by Crabby Dave's. As the council grew, it found accommodations upstairs in the old telephone building on East Third Street, above the old armory (Hartl Building) on West Second Street, the VFW Club on West Depot Street, and the old St. Matthews Lutheran Church on South Chestnut Avenue.

By 1968, the council recognized the need for larger facilities and built the new clubhouse at 400 West Upham on land donated by Mrs. Doris Rembs and Mr. Joseph Felhofer as a memorial to the late John Rembs. For nearly 50 years that KC Hall served the council and community well.
